- 3. The remote e-voting period remained open from 25<sup>th</sup> March, 2019 (9:00 A.M) to 27<sup>th</sup> March, 2019 (5:00 P.M) and thereafter, the members who did not exercise their voting rights through remote e-voting, were entitled to vote at the Extra-Ordinary General Meeting.
- 4. As per the information given by the Company, the names of shareholders who have voted by remote e-voting through the facility provided by CDSL has been blocked and One time Password (OTP) was issued only to those members who were present at the Extra Ordinary General Meeting and who have not voted through remote e-voting. The OTP was issued on registration of attendance after verifying shareholder's folio, DPID, specimen signature and number of shares held by the member, comparing with Register of Members/ Register of Beneficial owner as on cut-off date.
- 5. - 6. - 7. We have scrutinized the votes cast through electronic means and voting through electronic means at the Extra Ordinary General Meeting only for the purpose of this report.
